3. Consent Calendar

A. Consider approval of the minutes of May 18, 2019 Board of Director's meeting

Motion by Sacramento Adult Soccer League/second by Golden Gate Women's Soccer League to approve minutes of May 18, 2019 Board of Director's meeting. Passed unanimously.

4. Action Items

A. Consider reappointing Ric Olivas as CSAN representative on the California North Referee Association (CNRA) Committee

Motion by Javier Rodrigues/second by Golden Gate Women's Soccer League to reappoint Ric Olivas as CSAN representative on CNRA Committee. Passed unamiously.

B. Consider approving a \$100 per month stipend for CSAN Vice-President

Javier Rodriguez checked with our accountant that does our payroll and if the Vice-President receives a monthly stipend, he would have to pay taxes on it and CSAN would have to pay for worker's compensation insurance. For these reasons, Juan Zaldana, CSAN Vice-President, declined to receive a stipend.

C. Consider approval of the Ann Wagner Tournament

The Golden Gate Women's Soccer League requests permission to host their annual tournament. The tournament is being held on Saturday, August 24, 2019 at Beach Chalet.

Motion by Golden Gate Women's Soccer League/second by Monterey Peninsula Soccer League to approve the 2019 Ann Wagner Tournament. Passed unanimously.

D. Consider request from GGWSL for funds from 2019 State Cup

The Golden Gate Women's Soccer League requests funds that were budgeted for the 2019 Women's State Cup for cash prizes and marketing for the Ann Wagner Tournament.

Motion by Golden Gate Women's Soccer League/second by San Francisco Soccer Football League to approve \$2,500 for the GGWSL to use for prize money and marketing purposes for the 2019 Ann Wagner Tournament. Passed, 11 yes votes, 1 no vote, and 1 abstention.

Amended motion by Golden Gate Women's Soccer League/second by San Francisco Soccer Football League for an additional \$1,000 to cover field costs for the Ann Wagner Tournament. Did not pass, 4 yes votes, 7 no votes, and 1 abstention.

(We voted first on the amended motion, since that did not pass, we then voted on the original motion.)

There is an Income Comparison report that shows a six year comparison of income we have received. International games money is a large factor in income we receive from year to year.

Javier Rodriguez reports the last fiscal year (2017 – 2018) is being audited. The auditors are requesting a list of documents to complete the audit and some of those are documents that do not exist. The cost of the audit is \$15,000.

D. State Cup Committee Report

Juan Zaldana reported on a very successful 2019 State Cup. Sixteen (16) teams participated, eight (8) teams participated in the San Francisco regional competition at Crocker Amazon and eight (8) teams participated in the Sacramento regional competition at Davis Legacy Fields. The finals were held at Beach Chalet on August 3, 2019. The first and second place teams in the State Cup and Junior Cup are:
