#### California Soccer Association North Board of Director's Meeting Minutes April 18, 2020

Motion by Javier Rodriguez/second by Juan Zaldana to approve minutes of February 1, 2020 Board of Director's meeting and 2018 IRS Form 990. Passed unanimously.

#### 4. Officer, Staff, and Committee Reports

#### A. President's Report

#### 1. Assembly Bill 5

In 2019, the California Legislature approved AB 5, which changes the rules on independent contractors and employees. If categorized as an employee, the employer has to provide worker's compensation insurance, unemployment insurance, pay Medicare, social security and payroll taxes. If categorized as an independent contractor, the employer does not have those expenses. Historically, referees have been categorized as independent contractors, so leagues have not had the burden to pay any employee expenses to the state and federal government. CSAN and CYSA are coordinating with CNRA to lobby our state legislature for an exemption for referees to AB 5, so that referees can continue to be categorized as independent contractors.

For leagues that assign and pay referees directly, it is in your best interest to keep records of payments and file a 1099 Misc. form with the IRS for every referee receiving \$600 or more in compensation.

#### 2. USASA and its response to COVID-19

USASA has cancelled the following 2020 national tournaments due to the outbreak of COVID-19:

- Soccer Fest
- Hank Steinbrecher Cup
- National Amateur Cup

Recently, USASA switched insurance companies as K & K Insurance was going to increase our premiums. The new insurance company is USI and offers the same benefits as K & K, but at a lower cost (about \$100,000 decrease nationwide).

Tom Moore has contacted both USASA and USI and to date there will be no partial refunds on player registrations due to COVID-19. Tom has asked about the possibility of a reduced fee on player registrations for next year.

#### B. Vice-President's Report

#### 1. CSAN Executive Committee response to COVID-19

During the shelter-in-place ordered by the city and county of San Francisco, CSAN will take steps to ensure the health of CSAN employees and its league members. The CSAN office will be closed, however, Norma Sanchez will work from home and continue to receive phone calls into the CSAN office. Norma will be going into the CSAN office once a week to receive mail and pay bills. Rocio Samayoa will also work from home and with leagues to help them with whatever they need and will continue to register players.

#### 2. Orosi Soccer League

The Orosi Soccer League is a 12-team soccer league located outside of Visalia. Ernesto Valerio, President of Orosi Soccer League, is present today representing the league. To date, Orosi Soccer League has submitted their league annual form and paid appropriate fees.

Motion by Javier Rodriguez/second by Jeff Staben to approve Orosi Soccer League on conditional approval so they can begin submitting team forms and player registrations. Passed unanimously.

#### C. Treasurer's Report

Javier Rodriguez submitted our Profit & Loss statement covering the period from September 1, 2019 to April 10, 2020. Our income for this time period is \$169,088.53 and our expenses are \$205,705.47, for a negative balance of (\$36,616.94). Javier indicates that there will likely not be many (if any) international games this summer, so we may not get much income from international games monies in the next year or two.

#### D. Player and Team Registration Report

Norma Sanchez reports that there are pending registrations in the office from National Soccer League and they want to hold off registering players until more information is known regarding COVID-19.

#### E. Financial Audit

Javier Rodriguez reports that he met with Kenneth Pun, who is performing the audit, and it is not possible to complete the audit because of a lack of documentation that CSAN can provide.

Kenneth Pun recommends that CSAN retain their services for a cost of \$1,000 a month so that they can serve in an advisory role to give us recommendations on

record keeping and types of documentation that we should file, advise us on how to handle internal reviews, and they would file our annual income taxes.

Ric Olivas suggests that CSAN consult our corporate lawyer, Cherie Evans, for her recommendation on this matter.

#### F. 2020 US Soccer Annual General Meeting

Written reports were submitted from the delegates who attended the 2020 US Soccer Annual General Meeting in Nashville, Tennessee: Tom Moore, Juan Zaldana, Jan Mullen, Javier Rodriguez, and Norma Sanchez.

Tom Moore reports that CSAN was able to get a policy change approved to US Soccer's Policy Manual for information to be included in the minutes of National Board of Director's meetings.

Jan Mullen reports that US Soccer announced earlier this week the elimination of the Development Academy. No correspondence from the national office has been sent to notify our members of this decision.

#### 5. Discussion Items

#### A. 2020 CSAN Annual General Meeting

Alicia Yanow reports that she has looked at two hotels, Marriott Visalia and Tulare Hampton Inn and Suites, for the weekend of August 14 – 16, 2020 to hold our Annual General Meeting.

Alicia will inquire that if we make a deposit, will it be refundable due to COVID-19 cancellations.

#### B. 2020 CSAN Hall of Fame Dinner

No nominations to date have been submitted for the CSAN Hall of Fame.

#### C. Safe Sports Act

The Safe Sports Act was passed by the federal government and requires us as directors to be mandatory reporters. Mandatory reporters are required to report any observance of sexual assault, harassment, bullying, and any other sexual misconduct within 24 hours of the incident.

USI, the new insurance company for USASA, has hired Player's Health, a risk management company. What is being proposed is to require every team to have a minimum of one person acquire Safe Sport training certification and a background

check. USI is requesting that state associations survey their leagues to determine how many (if any) players, coaches, and managers currently have Safe Sport training certification and have completed a background check.

Rocio Samayoa sent an email to all league presidents requesting that they survey their league members on how many have Safe Sport training certification and a background check. To date, four (4) leagues have responded.

#### D. Update on COVID-19 Restrictions

CSAN is available to help leagues with correspondence to Parks & Rec departments for field permits, using CSAN and USASA letterhead once Shelter-in-Place restrictions are lifted.

Javier Rodriguez reports that CSAN cannot apply for a financial assistance from federal government CARES program due to COVID-19 since we are a 501(c)4 not-for-profit organization.

#### E. League Members on Restarting Competition

San Francisco Soccer Football League has hopes to begin on May 17, 2020.

Central California Soccer League reports that Sacramento Park & Rec plan to open on May 1, 2020.

#### 6. Good of the Game

#### A. Correspondence received by Officers, Directors, and Staff

Norma Sanchez sent out to each league Director's and Officer's insurance forms to be reviewed and signed and, to date, has only received a few back. League directors and officers can receive liability insurance at no additional cost, as long as the form is updated, signed, and submitted annually.

#### B. Conflict of Interest Disclosure Statements

It is an IRS requirement to keep a conflict of interest disclosure statement on file for each league director. This form must be signed annually by each league director. If you are a league director and have not already done so, please sign the conflict of interest disclosure statement and send it to the CSAN office.

Agenda Title: President's Report

#### **Detailed Description:**

1) Status of International Games Payments: At U.S. Soccer, Adrian Garabay has left the organization and has been replaced by Amy Hopfinger. We received a check from U.S. Soccer in mid-April in the amount of \$16,520.10. This covers the 1.25% of gross gate receipts that we get from certain international games that occur in Northern California. This check covers the payment for seven games going back as far as July 18, 2018. We are still owed the payment for the following three games. Ms. Hopfinger says that we have not been paid yet for these games because U.S. Soccer has not received its payment from the promoter:

- 2) <u>Safe Sport and Background Check Requirements</u>: A risk management company named Player's Health (<a href="https://playershealth.com/">https://playershealth.com/</a>) has been hired by the insurance agency that now provides our insurance via the U.S. Adult Soccer Association. They have advised that we must abide by the following rules:
  - a. If a team in CSAN travels out of California to play in a tournament, they must have <u>one player or coach</u> with them who has taken the Safe Sport training and has had a US Olympic and Paralympic Committee qualified background check in the past two years.
  - b. If a team in CSAN has one or more registered players who are under the age of 18 years, then <u>all</u> of the adult players and coaches on that team must take the Safe Sport training and have had had a US Olympic and Paralympic Committee qualified background check in the past two years.

The Safe Sport training is free and can be done online at any time. However, a qualified background check may cost as much as \$35 depending on how you have it done. CSAN is looking into the pricing of background checks to see if we can find the least expensive service for you.

It is also important to note that CSAN has been provided with no resources to enforce these requirements. However, if you have one or more under-age players on your team and you do not comply with the requirements in b. above, there is no guarantee that the insurance company will provide coverage if an incident were to occur.

Here is a hypothetical example: suppose you have three 17 year-old players on your roster. Your team has not complied with the requirements in b. above. On the way home from a game, one of the 17 year-old players (we will call him "Luis") joins three of your adult players and they go to a secluded beach to drink some beer. They all get pretty drunk. While two of the adult players are passed out, the remaining adult player (we will call him "Bob") sexually assaults the drunken, semi-conscious Luis. A few days later the parents of Luis find out that Bob sexually assaulted their son. They report the incident to the police and Bob is arrested. The police find out that Bob has a past history of sexual abuse and assault. Luis's parents then file a civil suit against Bob, the two adult players who went drinking with Bob and Luis, and the coach and the owner of the team. Normally, our liability insurance policy would most likely cover the coach, the owner and the two players who went drinking with Bob and Luis. (Because Bob committed a crime, he would probably not be covered.) However, when the insurance company finds out that the requirements described in b. above were not followed, it is likely that no liability coverage would be provided to anyone.

3) <u>Director's Biographies Project</u>: We propose to ask each CSAN Officer, Director and Member-at-Large to provide some amount of biographical information. This would include experience as a player, coach, referee, manager, league officer, volunteer and perhaps a little information about how you make a living. The purpose for collecting this information is to put it on our website to show who is on the Board of CSAN. As the oldest State Association in the United States we should project an image that is professional and sets a standard for other State Associations to follow. See the next page for an example.

**Detailed Description**: The following two member leagues of CSAN are incorporated as non-profit corporations in the State of California <u>and</u> maintain non-profit tax status as a 501(c)(3) or 501(c)(4) organization with the U.S. Internal Revenue Service:

- Golden Gate Women's Soccer League
- San Francisco Soccer Football League

Our other leagues either have no corporate status or have a suspended or dissolved corporate status with the California Secretary of State, or do not have a recognized tax exempt status. They may be operating as an unincorporated non-profit organization or possibly as a for-profit partnership or sole proprietorship.

The purpose of this proposed project is to assist our unincorporated member leagues to obtain the additional protection that comes from having and maintaining formal, non-profit corporate and tax exempt status.

This proposed project would have CSAN's attorney (Cherie Evans) develop templates for Articles of Incorporation and Bylaws for a California non-profit public benefit corporation. Interested member leagues would customize these documents for their league and then be assisted by the CSAN Executive Committee or by Ms. Evans in filing the appropriate application forms with the California Secretary of State, the California Franchise Tax Board and the U.S. Internal Revenue Service. Before actually committing to doing this work, we would determine how much Ms. Evans would charge. At a future board meeting we would determine how such services would be paid for.

**Detailed Description**: The U.S. Soccer Federation is developing a set of guidelines for return to soccer activities. They have named this program "Play On". They have published and will continue to update the information about the Play On Program on their website at:

#### https://www.ussoccer.com/playon

The Play On Program consists of five phases numbered 0 to 4. We are currently in Phase 0 (shelter-in-place, i.e. zero soccer activity). They have published exhaustively detailed information and protocols for only Phase 1 so far. Phase 1 involves small groups (no more than eight) players and one coach doing socially distanced training with balls on half a soccer field. NO contact is allowed between players and there are lots of other recommended rules intended to limit the viral exposure possibilities and limit the consequences if viral exposure occurs. Phase 1 is mostly designed so that youth clubs can re-open a certain amount of training for their players.

You can download a copy of the current Phase 1 protocols and guidelines from the website above.

It is important to note that we will not be back to normal competitive adult play until we reach Phase 4. Note also that the timing of the opening of new phases is up to local county health authorities in your County.
